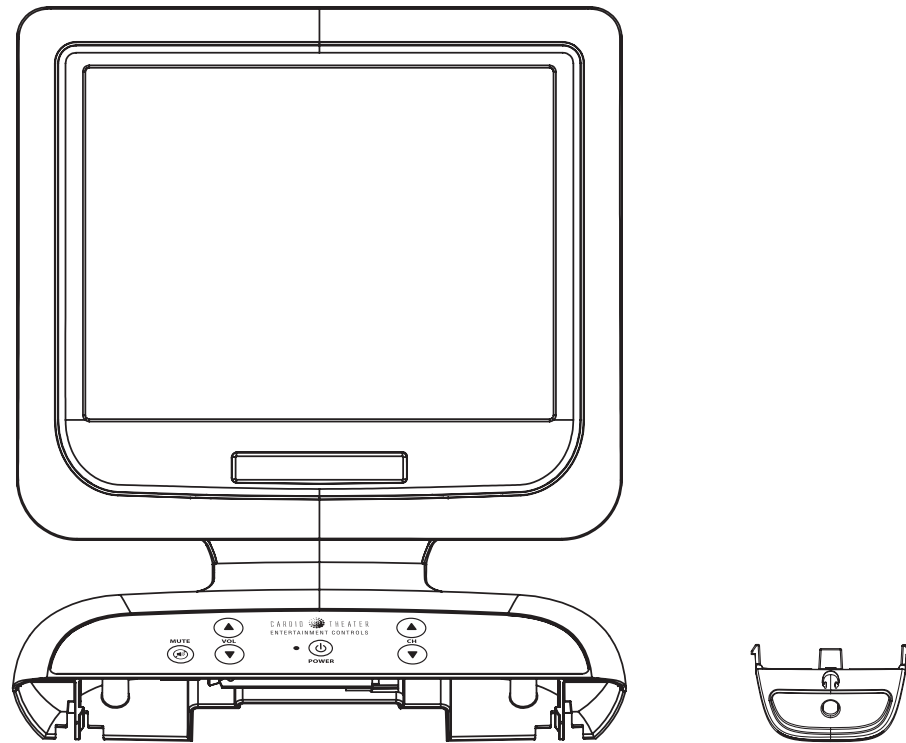


Personal Viewing System (PVS) Operation and Maintenance Guide



Important Safety Instructions

Always follow basic safety precautions when using this equipment to reduce the chance of injury, fire, or damage.

- Read all instructions before installing and using the equipment. Follow any labels on the equipment.
- Use the power adapter provided with the equipment. Plug the power adapter into an appropriate, grounded power outlet as marked on the equipment. Do not use accessory attachments that are not recommended by the manufacturer, as such attachments may cause injuries.
- Position power cables so that they are not walked on or pinched by items placed upon or against them.
- Make sure that the equipment has adequate ventilation. Do not place anything on top of or over the equipment. Do not use on a cushioned surface that could block the ventilation openings.
- Keep the equipment away from water and moisture.
- Locate the equipment away from sources of heat, such as radiators, heat registers, and stoves. Avoid temperature extremes.
- Avoid dropping anything on or spilling anything inside the equipment, because doing so can damage the electronics.
- Do not attempt to service the unit yourself except to follow the maintenance instructions found in this manual.

However, there is no guarantee that interference will not occur in a particular installation. If the unit does cause harmful interference to radio or television reception, which can be determined by turning the equipment off and on, the user is encouraged to try to correct the interference by one or more of the following measures:

- Reorient or relocate the receiving antenna.
- Increase the separation between the equipment and the receiver.
- Connect the equipment into a separate outlet that uses a different circuit than the receiver.

Consult a Radio Technician or an experienced radio/TV technician for help.

Before You Begin

The Cardio Theater Personal Viewing System (PVS) for the Precor cardio equipment adds personalized entertainment to workouts. Fitness facilities can add a PVS to any Precor exercise equipment that supports it. A person steps on the exercise equipment, selects a desired TV program using the Channel buttons, and begins exercising. The program appears on a bright, full-color liquid crystal display (LCD) directly in front of the person, rather than at a distance

on the wall. Depending on how the PVS is configured, Closed Captioning appears unless the person plugs in headphones. Volume buttons allow a person to change the audio level.

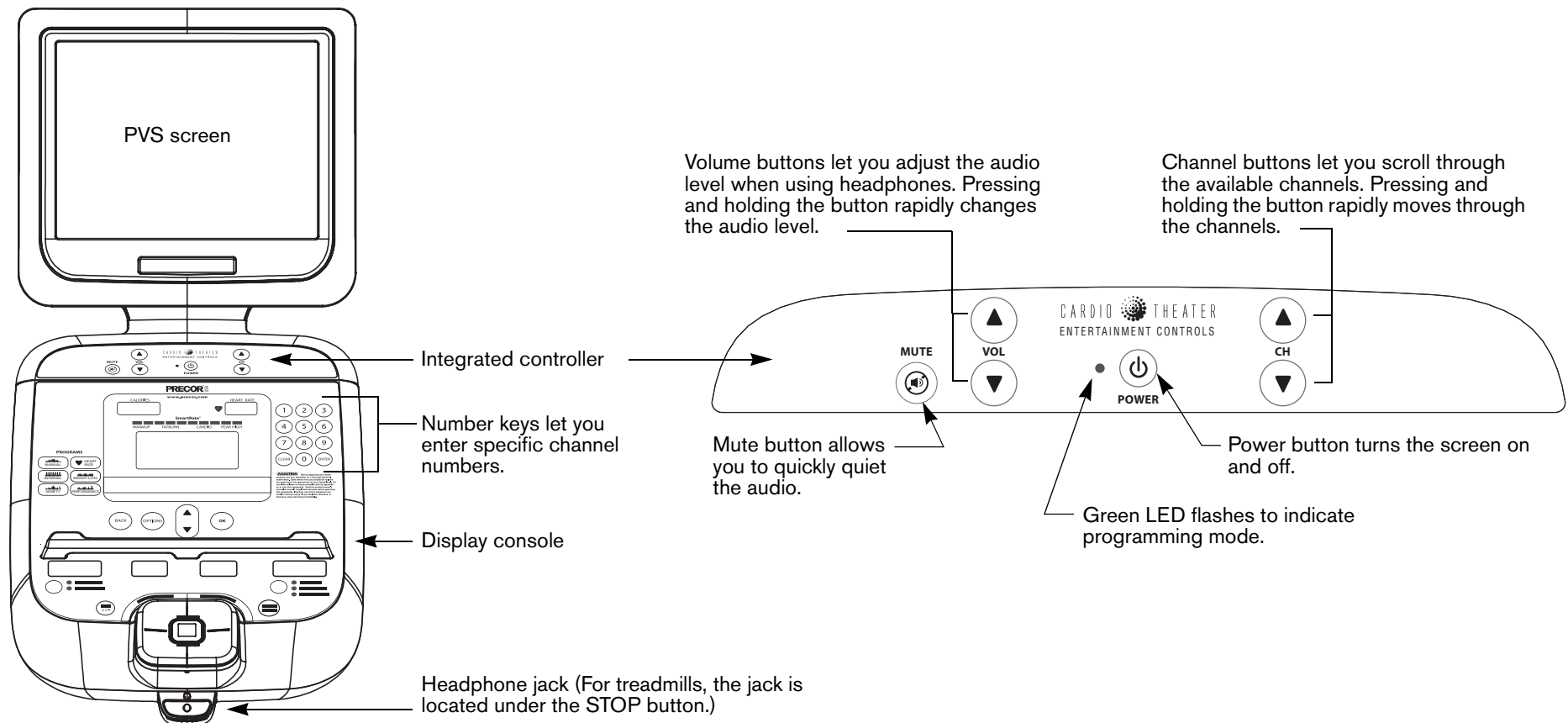


Figure 1: Overview of PVS screen and integrated controller

The screen is attached to a bracket which is installed behind the display console. The 6-button controller is integrated into the console design. Figure 1 shows the PVS screen and integrated controller.

Both the PVS screen and integrated controller receive power from a standard AC power outlet. They do not rely on power from the exercise equipment. Some functions on the PVS screen, however, such as setting up the Power-Up Channel feature, use the 0–9 keys on the display console keypad. With self-powered equipment, such as the EFX[®], you cannot set up those features on the PVS screen that use the 0–9 keys on the console unless someone is using the equipment, or the optional power adapter is connected to the self-powered equipment.

This guide explains how to set up basic options on the PVS that the fitness facility might want to use, such as Automatic Power On/OFF and Closed Caption On/Off. It also lists all of the video setup options available and covers any maintenance requirements. For proper operation and maintenance, please read this guide thoroughly and follow the instructions.

For information about installing the PVS on a display console, refer to the *Personal Viewing System (PVS) Assembly Guide*.

Suggested Tools

The PVS is designed so you can program it using a combination of controller buttons and keys on the display console. However, you may find some programming is easier with the optional remote control (CXITVRMT-102). Contact your Cardio Theater dealer to order one or more remote controls if desired.

You may want to add the optional power adapters to the self-powered equipment in your facility. To purchase the optional power adapters, check with your Precor dealer.

Obtaining Service

Do not attempt to service any of the equipment provided in the Cardio Theater PVS system except as described in this guide. For information about product operation or service, refer to the Cardio Theater web site at www.cardiotheater.com or contact an authorized Cardio Theater Technical Support Representative at 1-800-776-6695 or service@cardiotheater.com. Returning Equipment to Cardio Theater

To return equipment to Cardio Theater for any reason, you must contact Cardio Theater Technical Support and obtain a return authorization (RMA) number. When requesting the RMA number, explain why you are returning the equipment, for example you ordered too many controllers and the extra controller can be returned to stock, or the equipment needs repairs.

Important: *Equipment must be shipped with an RMA number in order for Cardio Theater to process it. Any equipment received without an RMA number will be returned to the sender.*

Initial Search for Channels

After you install the PVS hardware and all power and cable or antenna connections are completed, turn on each individual PVS screen and run the automatic search feature. This feature identifies the TV channels that are available. After the feature runs, the PVS screen displays only those channels that are available.

This section provides instructions for running the automatic search feature using either the integrated controller or the remote control.

Automatic Search with the Integrated Controller

Follow these steps to automatically search for the available channels on the PVS screen using the integrated controller. While you are in the Video Setup menu, if you do not press a button or complete a sequence within 15 seconds, the Video Setup menu disappears and the PVS screen will return to normal viewing mode.

1. Turn on the PVS screen.
2. Press both the Volume ▼ and Channel ▼ buttons simultaneously until the green LED begins flashing (about 5 seconds).

The flashing LED indicates that the PVS screen has entered the Video Setup mode. The Video Setup menu appears on the PVS screen.

3. Use the Channel ▼ button to move down to TV Install.

4. Press the Power button to select TV Install.
5. Press the Power button again to select Auto Search, which is already highlighted.
6. Select the appropriate mode for the input you plan to use by pressing the Channel buttons to move to that mode and then pressing the Power button. Typically, you will choose the Cable TV mode.

The screen shows the message “Scanning XX STOP: Menu key.” The XX changes as the automatic programming feature scans the available channels. This process may take several minutes to finish. When done, the lowest programmed channel appears on the screen.

Note: Ignore the “STOP: Menu key” message. You will not be able to stop the automatic programming process because the integrated controller does not have a Menu button.

Automatic Search with a Remote Control

If you have a remote control, follow these steps to automatically search for the available channels on the PVS screen. While you are in the Video Setup menu, if you do not press a button or complete a sequence within 15 seconds, the Video Setup menu disappears and the PVS screen will return to normal viewing mode.

1. Turn on the PVS screen.
2. Press the Menu button on the remote control. The Video Setup menu appears on the PVS screen.
3. Use the Channel – button to move down to TV Install.
4. Press the SEL button to select TV Install.
5. Press the SEL button again to select Auto Search, which is already highlighted.
6. Select the appropriate mode for the input you plan to use by pressing the Channel buttons to move to that mode and pressing the SEL button. Typically, you will choose the Cable TV mode.

The screen shows the message “Scanning XX STOP: Menu key.” The XX changes as the automatic programming feature scans the available channels. This process may take several minutes to finish. When done, the lowest programmed channel appears on the screen.

Note: You can stop the automatic programming process at any time by pressing the Menu button.

Using the Integrated Controller to Set Up Custom Features

Cardio Theater has customized a number of features that are commonly used in a fitness facility. The customization allows you to easily enable or disable a feature using the integrated controller. Use of these features is optional.

- **Automatic Power On/Off feature** causes the PVS screen to turn off automatically when headphones are removed and turn on when headphones are inserted.
- **Closed Caption On/Off feature** causes the screen to display Closed Captioning (CC1 standard) when no headphones are connected. This feature does not work when the Automatic Power On/Off feature is enabled.
- **Standby Channel feature** sets the PVS so it displays a specific channel when no headphones are connected. You might use this feature to display a TV channel guide, facility welcome screen, or default channel. This feature does not work when the Automatic Power On/Off feature is enabled.
- **Power-Up Channel feature** lets you specify a channel that will appear whenever the screen is turned on. You might use this feature if you offer an in-house channel.

This section provides instructions for setting up each of these features. At the end of this section, you will find a table that provides a quick reference to the buttons you press. Once you are familiar with setting up these features, you may find the table is all you need.

Important: You must use the integrated controller to set up these features. A remote control accesses the standard PVS features, not the customized Cardio Theater features.

Automatic Power On/Off Setup

The Automatic Power On/Off feature turns the PVS screen on automatically when headphones are inserted into the headphone jack. At the end of the exercise session, when the headphones are disconnected from the jack, the screen turns off after a period of time. This feature is typically used to conserve power and lengthen screen life.

If you enable this feature, do not enable the Closed Caption On/Off feature. The Closed Caption feature requires the screen to stay on when headphones are not plugged into the jack.

This procedure uses the integrated controller only.

1. Press the Channel ▲ and Volume ▲ buttons simultaneously until the green LED begins flashing (3 seconds). The flashing LED indicates that the PVS screen has entered Program Device mode.

Note: If you do not press a button within 15 seconds, the PVS screen will return to normal viewing mode.

2. Choose one based on what you want to do:

- To enable the feature, press the Channel ▲
- To disable the feature, press the Channel ▼

As soon as you press a button, the PVS screen returns to normal viewing mode. If you enabled the feature, the green LED flashes slowly. Otherwise, if the feature is off, the green LED remains illuminated.

Closed Caption On/Off Setup

With this feature, Closed Captioning (CC1 standard) displays on the screen when headphones are not plugged into the headphone jack. Closed Captioning stops displaying on the screen when headphones are inserted into the jack. This feature gives people the choice of using headphones to hear the TV program or not using headphones but simply reading the captioning.

Note: When this feature is enabled, people will see the PVS menu appear briefly while the preprogramming automatically turns the feature on or off.

Important: This feature uses preprogramming that moves through several layers of the PVS menu. To make sure that this feature works properly, you must not change the PVS programming for Closed Captioning. You cannot use CC2 standard with this feature.

If you enable this feature, do not enable the Automatic Power On/Off feature. The Automatic Power On/Off feature turns off the screen when headphones are not plugged into the headphone jack.

This procedure uses the integrated controller only.

1. Press the Channel ▲ and Volume ▲ buttons simultaneously until the green LED begins flashing (3 seconds). The flashing LED indicates that the PVS screen has entered Program Device mode.

Note: If you do not press a button within 15 seconds, the PVS screen will return to normal viewing mode.

2. Choose one based on what you want to do:

- To enable the feature, press the Volume ▲
- To disable the feature, press the Volume ▼

As soon as you press a button, the PVS screen returns to normal viewing mode. If you enabled the feature, the green LED flashes slowly. Otherwise, if the feature is off, the green LED remains illuminated.

Standby Channel Setup

This Standby Channel feature defaults to a specific TV channel or welcome screen when no headphones are connected. When this feature is enabled and when a person disconnects from the headphone jack, the screen changes to the standby channel.

If you enable this feature, do not enable the Automatic Power On/Off feature. The Automatic Power On/Off feature turns off the screen when headphones are removed.

To set up this feature, you must use the 0–9 keys on the display console keypad. This means that power must be supplied by the exercise equipment. The optional power adapter is a useful tool for self-powered equipment.

1. Supply power to the exercise equipment.
2. Press the Channel ▲ and Volume ▲ buttons simultaneously until the green LED begins flashing (3 seconds). The flashing LED indicates that the PVS screen has entered Program Device mode.

Note: If you do not press a button within 15 seconds, the PVS screen will return to normal viewing mode.

- To enable this feature, specify the desired channel using the 0–9 keys on the keypad. Then, press the Mute button on the integrated controller. The specified channel appears on the screen.

The integrated controller stores the channel in memory. The PVS screen returns to normal viewing mode and the green LED stops flashing.

- To disable this feature, press the Mute button without pressing any number keys.

Power-Up Channel Setup

This feature lets you determine what channel appears when the PVS screen is turned on. Your fitness facility can offer an in-house channel or special informative channel when the Power-Up Channel feature is enabled.

To set up this feature, you must use the 0–9 keys on the display console keypad. This means that power must be supplied by the exercise equipment. The optional power adapter is a useful tool for self-powered equipment.

- Supply power to the exercise equipment.
- Press the Channel ▲ and Volume ▲ buttons simultaneously until the green LED begins flashing (3 seconds). The flashing LED indicates that the PVS screen has entered Program Device mode.

Note: If you do not press a button within 15 seconds, the PVS screen will return to normal viewing mode.

- To enable this feature, specify the desired power-up channel using the 0–9 keys on the keypad. Then press the Power button on the integrated controller. The specified channel appears on the screen.

The integrated controller stores the channel in memory. The PVS screen returns to normal viewing mode and the green LED stops flashing.

- To disable this feature, press the Power button without pressing any number keys.

Quick Reference

Once you are familiar with setting up the customized Cardio Theater features, you may find the following table useful as a quick reference. Remember these features can only be set up using the integrated controller.

Using the Video Setup Menu

The PVS screen offers a number of features that are accessible only from the Video Setup menu. You can access the Video Setup menu from the integrated controller or a remote control. Access to this menu and its features should be limited to facility personnel.

While you are in the Video Setup menu, if you do not press a button within 15 seconds, the Video Setup menu disappears and the PVS screen will return to normal viewing mode.

Table 2 gives an overview of how to use the menu. Tables 3 and 4 show the main and second-level menus.

Table 2: How to use the Video Setup menu

Note: If you press the Mute button while the main Video Setup menu is displayed, the main menu will disappear. It will appear again if you press the Mute button again. The green LED flashes whenever the PVS is in Video Setup mode.

Table 3: Main menu

Picture	Allows you to adjust contrast, brightness, hue and other features to improve the quality of the picture shown on the screen.
Sound	Provides controls for changing the quality of the audio and adjusting audio through the speakers.
TV Install	Allows you to configure the PVS screen.
Caption	Displays any captioning provided by the programming. Captioning appears automatically when the PVS screen is muted.
V-Chip	Allows you to block unwanted TV programs based on different ratings.
OSD	Lets you set the language for on-screen displays and other OSD features.
Input	Lets you specify which input you want the PVS screen to use.
Information	Displays information about the PVS screen.

Maintenance and Troubleshooting

In general, the PVS screen and integrated controller require little maintenance and will rarely experience problems once installed. However, you may find the cleaning and troubleshooting information in this section useful.

This section also explains how to replace the headphone jack when it no longer provides good audio quality.

Cleaning the PVS

For the Precor exercise equipment, follow the daily cleaning instructions and cautionary statements found in the *Product Owner's Manual*.

Periodically dust the PVS screen with a soft clean cloth.

CAUTION: Do not use liquid cleaners or aerosol cleaners to clean the screen. Do not use any solvents such as alcohol and paint thinner, or acidic cleaners.

Each week, clean the integrated controller with a mild soap and water solution. Lightly dampen a soft clean cloth with the solution and wipe the controller. Do not use too much solution on the cloth or spray cleaning solution directly on controllers. Doing so could cause moisture to enter through the connector and damage the controller.

Troubleshooting the PVS

Table 5 may help you to understand and troubleshoot any problems that you encounter with the PVS screen and integrated controller. If the suggestions in the table do not help you solve the problems that you encounter, please contact Cardio Theater Technical Support.

Table 5: How to solve most problems

<i>What to Do</i>	
No power	Check green LED is lit. Make sure that the power cable connections are secure and the power cable is connected to a functioning outlet. Push the Power button.
No Closed Captioning	Make sure Caption is On under the Caption feature in the Video Setup menu. Closed Captioning may not be available on that channel; try a different channel.
Closed captioning is delayed	A delay between captioning and the actual dialogue is common in live broadcasts.
Screen turns itself off	Automatic Power On/Off feature may be enabled. The screen will turn off when headphones are not plugged into the headphone jack. Refer to <i>Automatic Power On/Off Setup</i> .
No picture	Make sure the correct TV System has been specified from the TV Install menu (in Video Setup menu). Make sure PVS screen is fully plugged into a power outlet. Push the Power button. Try a new channel; it may be station trouble. Turn the PVS screen off, and then turn it back on after one minute.
No audio	The PVS is designed to automatically decrease the audio after each person uses it. Increase the audio level with the Volume ▲ button. Check the headphone jack. Replace the headphone jack if necessary.
Poor picture	Adjust controls such as Brightness, Hue, and Sharpness under the Picture menu (in Video Setup menu).
Bars on screen	Try a new channel; it may be station trouble. Make sure video cable is connected to connector on the back of the PVS screen. Check for local interference.

<i>What to Do</i>	
Poor TV reception	Adjust Sharpness under the Picture menu (in Video Setup menu). Try a new channel; it may be station trouble. Make sure coaxial cable is securely connected to its connector on the back of the PVS screen. Check for local interference.
Ghosts in picture	Try a new channel; it may be station trouble. Make sure coaxial cable is securely connected to its connector on the back of the PVS screen. Check for local interference.
TV program cannot be watched	Specify channel using 0–9 keys or remote control. If necessary, rerun the Auto Search feature (see <i>Initial Search for Channels</i> .)

Replacing the Headphone Jack

When someone experiences no audio or poor audio quality (such as intermittent audio or crackling), you should check the headphone jack. The headphone jack is designed to be easily and quickly replaced at the facility. Make sure you have a new headphone jack (CX30315) before you begin.

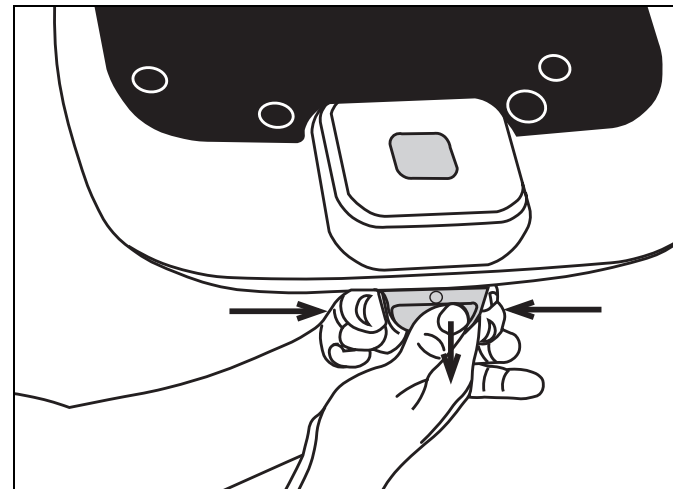


Figure 2: Grasp the headphone jack and remove it from the console

1. Firmly grasp the headphone jack, located under the display console. With one hand squeeze the sides near the top while pulling down with your thumb using your other hand. See Figure 2. You may find it helpful to wiggle the jack from side to side. The headphone jack should pop off the display console, with the audio cable still connected.

The headphone jack has two tabs on each side and one tab in the back. These tabs help to secure the headphone jack to the console.

2. Disconnect the audio cable. You can discard the used headphone jack.
3. Slide the stereo plug on the audio cable into the new headphone jack.
4. Replace the headphone jack into place under the display console. Line up the back tab with the back slot, feed the audio cable inside the console, and then snap the two side tabs into the two side slots.

Important: Do not stretch, crimp, or damage the cable. Cables damaged by improper installation will not be covered by the Limited Warranty.

Limited Warranty

Precor Incorporated ("Precor") warrants all new Cardio Theater products to be free from defects in materials and manufacture for the warranty periods set forth below. The warranty periods commence on the invoice date of the original purchase. This warranty applies only against defects discovered within the warranty period and extends only to the original purchaser of the product. Parts repaired or replaced under the terms of this warranty will be warranted for the remainder of the original warranty period only. To claim under this warranty, the buyer must notify Precor or your authorized Cardio Theater dealer within 30 days after the date of discovery of any nonconformity and make the affected product available for inspection by Precor or its service representative. Cardio Theater product deemed defective by a Cardio Theater representative, will be issued a return authorization number. **Precor will not accept returns without a return authorization number.** Precor reserves the right, at their option, to repair or replace the product after verification of defect. Product that fails after the warranty period expires will be repaired or replaced at the current part and labor pricing after authorization from the customer. Repairs are warranted for 90 days.

Precor's obligations under this warranty are limited as set forth below.

 - b. it has not been subjected to accident, misuse, abuse, improper service, or mechanical, electrical or non-Precor modification.
 - c. claims are made within the warranty period.
2. This warranty does not cover damage or product failure caused by electrical wiring not in compliance with electrical codes or Precor owner's manual specifications, or failure to provide reasonable and necessary maintenance as outlined in the owner's manual. **This warranty excludes misuse or failures of, for example, poor quality CD's, multiple discs inserted in the player, failures caused by home-produced copies of discs, etc.**
3. Except in Canada, Precor does not pay labor outside the United States.
4. Warranties outside the United States and Canada may vary. Please contact your local Dealer for details.

This Limited Warranty shall not apply to:

1. Software (PROM) version upgrades.
2. Normal wear and tear, consumables and cosmetic items, including, but not limited to the following: labels.
3. Repairs performed on Cardio Theater products missing a serial number or with a serial tag that has been altered or defaced.
4. Service calls to correct installation of the product or instruct owners on how to use the product.
